Fundraising Agreement:

This document illustrates the obligations between Fundraising Membership LLC., henceforth known as "Provider", a Georgia company located at 910 Athens Hwy, Suite K-214, Loganville, GA 30052 and

, henceforth known as "The Organization" or "ORG", in good faith for the mutually beneficial arrangement of a fundraising project with the intent to produce revenues for ORG and Provider.

Obligations of Fundraising Membership LLC:

Provider will provide a replicated website for ORG which will be able to receive funds for donations and provide a registration code to the donor for a HotelsETC.com Annual Standard Membership. The Membership allows the donor to access deep discounts, within the HotelsEtc.com Network in the hospitality, entertainment and travel industries.

Provider will provide a replicated website for ORG which will be able to receive funds for donations or sales of Annual HotelsEtc.com Memberships, which supply members with discounts.

Provider will supply ORG with a website login to a back office where ORG can upload photos, a logo, a mission statement, and a description of their mission and methodology to receive donations.

Provider will provide Electronic/Digital Annual Memberships to donors or persons who purchase Annual Memberships with the intent of ORG receiving donations.

Provider will give ORG 50% of the Membership price, not including merchant fees, activation fees or Dream Vacation Vouchers, at the end of the fundraising period as specified in this agreement.

Obligations of Organization:

ORG will promote their website to their members and potential donors so they may make donations or purchases of Annual Memberships provided by Provider.

ORG will receive a "Promote" button on their replicated website. ORG will then refer members of their organization and others who may wish to help them raise funds to click on the promote button where each member can create their own extension of the website and promote the fundraiser for ORG.

For example, Fundraising membership.com/organizationname/member-name.

Each member will be encouraged by ORG to make a donation from their chosen extension of the website. ORG will also encourage all members who have registered to promote to elicit donations from friends, family, businesses, acquaintances, and post their links on all social media they may have.

Fundraising Membership LLC "Provider" will provide content for marketing through social media, and a flyer template that ORG can print and use in an effort to elicit more donations.

All donations will be collected and disbursed via Fundraising Membership LLC.

Facilitation of the Fundraiser:

The fundraising time period for ORG will end on the date specified in this agreement. The organization will then receive 50% of Membership sales/donations by Wire Transfer or Company Check paid by Provider.

Dream Vacation Vouchers

ORG agrees to purchase a minimum of 1 Dream Vacation Code to be used in their Prize Give-Away Drawing as specified in this Agreement.

Dream Vacation Vouchers purchased require no up-front payment and the cost of the Dream Vacation Vouchers will be deducted from the earnings of ORG and/or Agent as specified in this agreement.

Dream Vacations have a retail value of up to \$3,000. ORG is responsible for purchasing a minimum of 1 Voucher at \$400. Additional Vouchers may be purchased for \$300 each.

Prize Give-Away and Redemption:

ORG will be responsible for holding a fair "drawing" to determine the winner(s) of the Dream Vacation Vouchers. ORG will then provide the winner(s) with the voucher code(s) and send them an email which Provider provides to ORG with relation to the Dream Vacation Vouchers. The organization may choose how to facilitate the drawing for the winners.

Winner(s) of the luxury Dream Vacation Vouchers(s) may enjoy luxury accommodations in one of many five star resorts in Mexico or choose deluxe accommodations in Orlando, Florida or Las Vegas, Nevada.

Dream Vacation Voucher Winners will be required to pay \$9 per night city/state tax for the weekly accommodations. Winner(s) are also responsible for any additional upgrades, food and transportation to and from the resorts. Some additional fees may apply depending on the resort chosen by the winner(s).

Winners will have a period of 12 months and up to 18 months to "book" their resort vacation using the voucher provided.

Each donor will receive an entry or entries to win a Dream Vacation Vouchers based on the amount of their donation.

In this agreement, ORG may specify how many vacations they would like to offer for their fundraiser. There is a minimum of 1 Dream Vacation Vouchers that must be purchased from the revenues of the Fundraiser.

Payment by Provider to Organization:

Within 7 business days of the ending period of the Fundraiser, as specified in this agreement, ORG will receive a check or wire transfer for 50% of the gross revenue, not including merchant fees, activation fees or specified Dream Vacation Vouchers, from the Fundraising Membership LLC. ORG will be responsible for providing accurate mailing information for a check or Bank Wire Deposit Information.

Benefits to the Donor(s):

Once funds have been received from donor, the donor will receive an electronic link to register their Standard Annual Membership with HotelsEtc.com. At this point, the donor will be able to create their Hotels Etc. INC membership account, log in to their own back office, book hotels, condo vacations, car rentals, cruises and more at potentially substantial discounts, which can help the donor to potentially save more than the amount of donation.

The donor will also receive the appropriate amount of entries to win a "Dream Vacation" Voucher as specified by the website created for ORG.

Donation Tracking and Visibility:

Fundraising Membership LLC. will provide a back office tracking system to ORG that will show the donations made through the website Provider creates for ORG, so the organization can view and track all sales / donations made for ORG. This will include: the organization's promoters, donors name, the amount donated, and the email of the donor.

The database back-office tracking system will show the codes of each donor in the event they do not receive the email and need to contact the organization to find their specific Membership Activation Code.

The donation website will be hidden from public view at the end of the fundraiser termination date and may be reactivated with the signature of a new Fundraising Agreement.

Starting a New Fundraiser:

When the organization is ready to start another fundraiser, a new contract must be signed, and their website will be turned back on the specified start and end dates of the next fundraiser.

Minimum Commitment:

ORG agrees to generate a minimum of 50 donations by the end of the Fundraiser timeframe. In the event 50 donations at a minimum of \$50 each are not received by Provider from ORG's Fundraising Website, Provider will bill ORG for the minimum amount due and this must be paid within 30 days after the Fundraiser ending date.

ORG will purchase a minimum of 1 Dream Vacation Voucher at \$400. Additional Vouchers are available for \$300 each.

Tax Status:

Organization will supply Provider with tax exempt status information. If the ORG is not tax exempt, ORG will supply an EIN or other Tax Identification Number to Provider and will receive a 1099 form from Provider.

Getting Started:

By printing, filling out and signing this contract, ORG agrees to the terms of this contract and you attest that you are the authorized signer for the Organization who is in control of directing funds received by your Organization.

In order to start a Fundraiser with our program, a representative of the Organization must be approved by Provider.
